#### From the Chief Justice of Bhutan

In the pages that follow, we update you on the progress we have made in implementing our plans and objectives for the year 2020. As I write, the spread of corona virus has thrown the world into disarray and dealing with post pandemic will require changes in how we normally function. Post pandemic, no one knows but one thing is absolutely certain is that it will be different. Technology will play a major factor in navigating post pandemic. Judiciary will have to leverage on technology to rewrite the manual on how we function to ensure sustainability.

The pandemic brought about profound changes in the day-to-day operations of courts. In matter of days the courts shifted from in-person to virtual for all but essential court services during the lockdown. Key to the preservation of essential court services has been the cooperation among judges and court personnel across the country, and the IT services and personnel. Courts have shared what works and what hasn't and have worked together to navigate this public health crisis. While this has been a year of unimaginable challenges, it has also been one of great achievements and lessons for the future.

Necessity is the mother of invention. No truer example of this adage exists than the transformation courts underwent in last two lockdowns. Hearings of all sorts went virtual. Judges eventually used a wide range of available audio and video conferencing tools. But this effort required more than just new technology. Judges needed to adopt innovative approaches to conduct court proceedings.

This annual report unlike in past has undergone major changes in the format and structure. The information presented are more structured and presented in a bite size manner for all reader.

This Annual Report documents our evolution and our strategic objectives. I invite you to have a look for yourself and see just how Judiciary is today – nearly 50 years after its establishment. I hope you enjoy reading this report.

#### INTRODUCTION

The maturing of our democracy has increased the growing need for court services by members of the public. This has necessitated that we find new ways for the public to access the courts in order to augment the traditional access methods. As such, we have increasingly used technology to improve court accessibility and processes. Mindful of the impact this might have on access to justice, plans are underway for automation and digitalization of court records in order to continue to improve efficiency in information.

The Judiciary is one of the pillars of our constitutional democracy and plays a significant role in ensuring that the rights of Bhutanese are protected. The Constitution enshrines the rights of all people and affirms the democratic values of human dignity, equality and freedom. These democratic values must be respected, protected and fulfilled by the State and all organs of the State. The Judiciary continues to be instrumental in preserving democracy by ensuring that our laws, including the Constitution, are respected and upheld. The Judiciary, as an independent arm of State, has also been instrumental in the fight against corruption. In light of the critical role played by the Judiciary in our constitutional democracy, it is important that it is given the necessary support it deserves. Increasing access to justice remains one of our priorities. It is because of this reason that we have established e-litigation.

The trust of the public must be continually nurtured if it is to survive. Our operations at every level, from individual interactions between judiciary and members of the public to system-wide performance, affect the public's confidence in us.

It has become crucial for Judiciary to develop a strategic plan that provides the Court with a roadmap for improving court users' experience and our ability to serve the public generally.

This report describes just some of what the Court has done and is going to do to achieve them.

As important as the past and planned achievements are in fostering public trust, there is much in the daily business of the Court that inspires confidence. Some of this occurs in public, but much of it does not. Helping parties end a dispute that perhaps once seemed impossible to resolve, listening to a witness carefully and with an open mind, writing reasons for a decision so that the parties and the public can understand the outcome of a trial, and every other part of the Court's day-to-day business are how we deliver justice in accordance with the law.

We hope that this report enlightens readers about the workings of our Court and illustrates both how we have seized the initiative to deliver real improvements over the 2019-2020 period and our ongoing work to remain a trusted, effective institution in an era of great change.

#### Recruitment of Court Registrars and Bench Clerks

Four toppers of the Post Graduate Diploma in National Law (PGDNL) from the Royal Institute of Management (RIM) joined the Judiciary as Court Registrars with effect from 1st January, 2020. #### Workshop on Drafting and Finalization of Documents for Electronic Litigation



The Judiciary of Bhutan in collaboration with the UNDP organized a workshop on "Drafting and Finalization of Documents for Electronic Litigation" from 15th July to 17th July, 2020 in Paro. The opening session of the workshop was graced by Drangpon Tshering Dorji, Registrar General of the Supreme Court and Her Excellency Azusa Kubota, Resident Representative, UNDP. The three-day workshop was attended by the participants from the Judiciary, UNDP, UNICEF, GNHC, NCWC and i-Technologies. With the global pandemic and much felt need to infuse justice with technology, the Judiciary has decided to establish electronic litigation in Bhutan. Therefore, the Judiciary decided to draft the Rules and Regulations on Electronic Litigation, 2020. In addition to developing rules and regulations on electronic litigation, the Judiciary, through this pilot project, aims to upgrade or enhance features of the existing Case Management System (CMS) to support services under electronic litigation. With financial and technical assistance from the UNDP, the Judiciary has decided to establish a pilot project to establish electronic litigation in Bhutan. The objective of the project was to establish a pilot electronic litigation system in selected courts to enhance easy access to justice for people of Bhutan. The workshop was the first step towards developing and establishing electronic litigation in Bhutan. The purpose of the workshop was to develop and finalize three essential documents for electronic litigation namely:

(1) Rules and Regulations on Electronic Litigation; (2) Action Plan for Implementation of Electronic Litigation; and (3) Terms of Reference for Technical Assistance.

The BNLI organized the training to further enhance the capacity of bench clerks to discharge their duties professionally. They were trained in determining the true intention or the purpose of the Legislature in enacting the particular laws; and familiarized with the various rules and principles of interpretation of laws.

#### Workshop on ADR/Mediation and Pro bono Legal Services



The Bhutan National Legal Institute conducted a two-day Workshop on ADR/Mediation and Pro bono Legal Services to Enhance Access to Justice from 28th to 29th July, 2020. The Workshop was facilitated by Justices of the Supreme Court and High Court, international and national experts. It was attended by 25 professional practicing lawyers. The opening ceremony was graced by Justice Kuenlay Tshering of the Supreme Court.

#### Visit by PGDNL trainees

On 5th August 2020, the Post Graduate Diploma in National Law trainees (Class of 2020) of the Royal Institute of Management, Semtokha visited the Supreme Court, High Court and BNLI on an educational excursion. The delegation was led by Justice Kuenlay Tshering, who teaches Constitutional law at the RIM as a Visiting Faculty. The trainees learned about judicial procedures and appellate norms of adjudication and trials. The program was aimed at making the course more experiential and immersive by familiarizing the trainees with the court related functioning and judicial profession.

Justice Duba had been serving as the officiating Chief Justice of the High Court.In accordance with Article 21(11) of the Constitution of the Kingdom of Bhutan, the Chief Justice of the High Court is appointed from among the Drangpons of the High Court or from among eminent jurists by His Majesty on the recommendation of the National Judicial Commission.

#### 1. Major Achievements of the Judiciary

#### Institutional Strengthening

To strengthen the Judiciary and to enhance trust and confidence of the public, His Majesty The King appointed the Chief Justice of Bhutan, the Chief Justice of High Court followed by the Justices of the Supreme Court and High Court.

The High Court now has nine Justices including Chief Justice to set the required quorum as mandated by the Constitution of Bhutan.

#### **Establishment of Court Annexed Mediation (CAM)**

CAM was instituted in Dzongkhag and Dungkhag Courts. It was initiated as a part of judicial reform to enhance access to justice and promote harmony in the society. It is aimed at providing opportunity for litigants to opt for negotiated settlement with an assistance of a neutral in-house judicial mediators at any time during the process of litigation. Her Royal Highness Azhi Sonam Dechan Wangchuck graced the inauguration of CAM in Punakha Dzongkhag Court on 28th October, 2019.

#### **Infrastructure Development**

To provide access to justice for people in the remote corners of Bhutan and to promote structural independence of the Judiciary of Bhutan, the office has started construction of Courts and residences for judicial personnel in Gasa, Sakteng and Weringla, the remotest places in the country. The Courts are not only expected to provide a dignified office for judicial personnel to work but also give prominent access point for our litigants in times of difficulties.

Under the funding of the Austrian Development Agency (ADA), the Judiciary has also started the construction of a Dzongkhag Court in Paro.

#### **Electronic Litigation (e-litigation)**

The launching of the first phase on a pilot basis took place in April 2013 at the Commercial Division of the Supreme Court. The system will be extended to other divisions of the Supreme Court (except for the Family and the Criminal Divisions). The e-judiciary will be implemented in these Divisions and in all subordinate courts during Phase II of the modernization of the JudiciaryAs a measure to provide unimpeded access to justice for all during the COVID-19 times, The Judiciary of Bhutan in collaboration with the UNDP has initiated a pilot e-litigation. The works started since July 2020 with the incorporation of e-litigation process in the existing Case Management System of the Judiciary. We have also developed rules and regulations to facilitate the process once it rolls out by the end of January 2021.

In this pilot project, fourteen Courtrooms throughout the country will be equipped with audio visual equipment to hear cases online/remotely. The litigants can attend hearings from the place they reside without having to travel all the way to Court breaching COVID-19 protocols and health instructions. If this pilot project becomes a success, the Judiciary envisions establishing remote hearings in all Courts.

#### **Development of Judiciary Strategic Plan (21st Century Judiciary Roadmap)**

The Judiciary is one of the branches of the Government with the constitutional mandate to safeguard, uphold and administer justice fairly and independently without fear, favour or undue delay in accordance with the Rule of Law to inspire trust and confidence. The Judiciary must uphold and protect the freedom and rights of the citizens against the strong and marauding power of the state, the wealthy and the powerful.

The proliferation of Acts and the increasing awareness in the public has increased the case load of the Courts around the country. With such magnitude of cases, it is imperative that the Judiciary take proactive measures in meeting the challenges presented before it. The Judiciary must evolve with the changing needs of the public and be relevant.

In the current 12th FYP, the Royal Government of Bhutan is striving towards creating a just, harmonious and sustainable society. Strengthening justice services and institutions is one of the National Key Result Areas to create a just society where every citizen is treated equal and has access to justice without any impediments. It is therefore, immensely important that there is a strong Rule of Law where laws are prospective that fulfils the changing needs of the time and people.

During the 112th National Day Celebration at the Changlingmithang in Thimphu, His Majesty The King decreed that "The government, lawmakers, civil service, and institutions must undertake the responsibility of restructuring and improving our laws, policies and procedures." Inspired by this profound statement of His Majesty the King, the Judiciary of Bhutan has started to draft our Strategic Plan (21st Century Judiciary Roadmap) in line with the development of 21stCentury Economic Roadmap by the Government. Currently, we are conducting public and stakeholder consultations to garner wider views and expectations. The Strategic Plan which is for a span of ten years (2020-2030) is expected to provide direction and guidance to evolve Judiciary as a 21st Century Judiciary easily accessible and open to constructive feedbacks.

#### **Development of Child Justice Concept Paper**

As a signatory to the Convention on the Rights of the Child (CRC), Bhutan has the obligation to pursue its objectives. Besides, the Child Care and Protection Act, 2011 (CCPA), which was enacted in pursuant to the objectives of the CRC, lays down provisions for an efficient and responsive child justice system. The fourth paragraph of the Preamble of the CCPA provides that the Act is enacted "In order to consolidate and provide care, protection, guidance, counseling, treatment, development, rehabilitation, adjudication and disposition of matters relating to children in conflict with law in the most favorable manner and in the best interest of the child..."

Further, Section 6 of the same Act provides that "The child justice system is essential to uphold the rights of children keeping them safe and promoting their physical and mental well-being." For an efficient child justice system, both legal framework and infrastructures are equally important. While Bhutan has adequate legal arrangement in the form of the CCPA, which provides for child justice in detail, it lacks the infrastructures that are necessary to administer child justice. Some features of this aspect of child justice are child-friendly courtrooms and waiting rooms, detention rooms, and technological facilities that ensure the protection of children's privacy especially during trials.

Projects that are proposed towards realizing the goals of an efficient child justice system require adequate fund. The fund, in turn, requires a clear plan and programme for its efficient utilization and functioning. Therefore, the Judiciary has developed a Concept Paper to address this and strengthen child justice system in accordance with the aims and objectives of the CCPA.

Bhutan, as a developing country, has not been able to implement the CCPA provisions as much as the concerns relating to child justice. However, some initial steps have been taken beginning with the establishment of a specialized Family and Child Bench in Thimphu District Court. Infrastructures, facilities and procedures that are vital for a child-friendly court are instituted in the Bench. However, the other courts of the country do not have such facilities. In this regard, it has become important for the Judiciary to develop and promote infrastructures for child-friendly courtrooms for an efficient child justice system in other courts of Bhutan too.

The Concept Paper will act as the basic framework document for projects geared towards an efficient child justice system. The Judiciary is expected to play an important role as an institution administering justice to provide services befitting the ideals of an efficient child justice system. Since Bhutan is in its initial stages of establishing the child justice system, other countries with well-developed child justice system can be a source of inspiration to begin with. Study visits to familiarize with exemplary child justice system and courtrooms are an important aspect of training for establishment of child justice system. Similarly, procurement of equipment that are integral to development of child-friendly courtrooms is an equally important aspect. With the concept paper endorsed, the Judiciary has already started implementing it.

#### Development of Concept paper for Justice Garden and Waste Management

While granting audience to the officials from the Royal Bhutan Army, Royal Bhutan Police, Secretaries of Ministries of Education and Works and Human Settlements, CEO of Druk Holdings and Investments, Judiciary, Thimphu Thromde, National Environment Commission, Dessups, National Housing Development Corporation Limited, and Non-Governmental Organizations on 30 October 2020, His Majesty The King commanded on tackling waste management in the country to contribute to the national pride and cleanliness. His Majesty commanded that the first and the foremost thing we could do is to have our own backyards cleaned and well managed. In this regard, His Majesty emphasized embarking on waste management in a phase manner as follows:

Phase I: Individual institutions to take responsibility of waste management within their area.

**Phase II:** Develop and implement sustainable waste management based on the zones created during the Covid-19 lockdown period.

**Phase III:** Landfill management and installation of practical infrastructures and technologies. In obedience to His Majesty the King's command, the Judiciary has developed the Standard Operating Procedure to be implemented by Courts around the country. The document has been approved and we are exploring for funds to take up the activity for effective management of waste and strive towards zero-waste in the Judiciary.

Similarly, in obedience to His majesty The King's command, the Judiciary has developed a Justice Garden project paper for beautification and gardening projects for the Royal Court of Justice which is soon going to be implemented.

#### **Video Conferencing System (VCS)**

The Bail and Remand hearings conducted through VSC enables most accused persons on remand and witnesses, particular the "vulnerable" ones to be heard without the need to be physically present in the courtroom. The VCS obviates the need to incur time and expense of transporting accused persons to the Court and the associated risks thereto. In order to function properly the VCS has been upgraded with better top notch equipments. This has cut down the operating costs by communicating with the prisons through internet and provide for a more secure communication between the Prisons and the Courts.

#### 2. Challenges

The following are some of the Challenges of the Judiciary that needs to be addressed.

- A perceived lack of trust and confidence in the courts and justice sector with a social stigma existing if people need to go to court. This is related to limited awareness of laws and the role of an independent Judiciary.
- 2. Consistency in decision-making and in the application of procedures and systems also provide challenges to accessing the courts (including the standardization of process across all courts). These have the potential to impact on the quality of decision-making and to create uncertainty in the system as a whole.
- 3. Ongoing professional capacity development at all levels is seen as a challenge within the Judiciary. While all judicial officers have law degrees, and a significant number have masters of law, court administration capacity is lower. The secretariat/administration need to be strengthened both in terms of number and professionalism to allow judges to adjudicate cases effectively. Besides, it is a challenge to keep the lower level judicial personnel motivated. Added to this, with increasing complexity in the cases being heard, and the establishment of several specialized benches, specialization is seen as a necessity.
- 4. While the Judiciary is seen as being independent in its decision-making function, it is not independent in terms of its administration (both personnel and financial) and finances. Registrars, Bench Clerks, and Administrative/finance Personnel are administered by the Royal Civil Service Commission and are governed by the Bhutan Civil Service Rules. This results in the Judiciary not being able to directly and effectively manage its non-judicial human resources. Additionally, financial independence of the institution is limited as budgets are subject to approval, refinement, and prioritization by the Ministry of Finance. The Judiciary has no financial and budgetary independence. This still continues to be a major challenge in the independent functioning of the office. Judiciary is one of the branches of the government whose mandates spread across 20 Dzongkhags and 15 Dungkhags. Despite it, the share of budget it receives from the government to undertake its mandates continue to remain less than a Ministry. Given such constraints, the Judiciary is not able to build adequate infrastructure across the country and develop its human resource capacity through provision of timely training and skill development opportunities.

- 5. Recognizing the threat posed with the nature of job, strengthening security for judges and justices to protect them from threats by parties is imperative. In this way judicial officers will be able to perform their professional functions more effectively without fear from threats, intimidation, hindrance, harassment, or improper interference.
- 6. Improving utility of the case management system is also a key challenge for the Judiciary to: i) inform the planning, management, and operations (internal); ii) data is integrated with other justice institution's (coordination), and iii) case, performance, and accountability-related data is available to the public.
- 7. Low levels of legal literacy and limited access to legal advice result in most litigants appearing in Court in person as pro se (unrepresented) litigants. This is exacerbated by a lack of operational legal aid and alternative dispute resolution mechanisms/centers.

# CASE REPORT

a) Overview In 2020, 2707 cases were carried forward from 2019 and 6998 new cases were registered including the appeal cases in the High Court and Supreme Court. In the Dungkhag Courts and Dzongkhag Courts, in total, 5980 cases were registered. Thimphu and Phuentsholing Courts had the highest number of registered cases among the Dzongkhag and Dungkhag Courts respectively. The total case pending for 2020 stood at 2873 cases of which 342 cases are pending for more than 1 year. In total, 6832 cases were decided. The reason for some courts having higher numbers of registered cases can be attributed to higher population and concentration of economic and social activities. It must be highlighted that a high disposal rate of cases among all the courts can be attributed to the in-house rule of disposing the cases within one year. The cases pending for more than a year is due to circumstances such as waiting for the forensic report, signature or thumb impression verification from experts outside the country, complexities of cases, absconding respondents, and inability to trace witnesses.

b) Category of Cases In 2020, a total of 3657 civil cases was registered out of which monetary cases top the list with 1674 cases. Compared to 2019, there is decrease of more than fifty percent in monetary cases. On the other hand, 1205 criminal cases were registered in 2020, which is an increase of 3 percent as compared to 2019. Amongst the criminal cases, Assault and Battery top the list with 307 cases.






Types of Case Disposal of Larger Bench, High Court


