Overview of Case Report

Dungkhag Courts registered 2019 new cases in addition to 384 cases carried forward from 2022. The Court disposed of 81.8 percent of the total cases, of which 4.12 Percent appealed to Dzongkhag Courts. The year saw a total of 437 cases pending before the Dungkhag Courts, of which 17.39 percent is pending beyond 12 months.

Dzongkhag Courts registered 6981 New cases in addition to 1132 Cases carried forward from 2022. The Court disposed of 86.78 percent of the total cases, of which 6.55 Percent appealed to the High Court. The year saw a total of 985 cases pending before the Dzongkhag Courts, of which 5.48 percent are pending beyond 12 months. Likewise, the Time-bound Bench registered 41 new cases in addition to 53 pending cases from other courts. Of that, the Bench decided 14.89 Percent of cases with 48 cases pending beyond 12 months.

The High Court registered 547 new cases in 2023 in addition to 65 cases pending from 2022. Of that, the High Court disposed of 91.99 per cent of the total cases with no cases pending beyond 12 months. Of 563 cases decided, 39.78 percent appealed to the Supreme Court.

The topmost court had an opening balance of 139 cases with 249 new registrations in 2023. The Supreme Court decided 81.95 percent of cases. Of the total 70 cases pending, 1.42 percent are pending beyond 12 months.

Overall, the Judiciary registered 9837 new cases with 1773 cases carried forward from 2022. Of this, the Judiciary disposed of 85.30 percent. Of the total 1621 cases pending in 2023, 11.04 per cent of cases are pending beyond 12 months. Beside these figures, the courts across the country are also engaged heavily in hearing and deciding miscellaneous matters, which includes cases registered as well as those dismissed and matters relating to the issuance of Marriage Certificates and notarization of documents.

5.2. Evaluation

In pursuance of the judicial will for judicial excellence and a transformative justice system that is responsive to the emerging needs of the people and country, the first judicial performance review and evaluation of the Dzongkhag and Dungkhag Drangpons was conducted in December 2022. Total of twenty-five Dzongkhag Drangpons and six Dungkhag Drangpons actively participated in this evaluative process. This evaluation promotes and encourages meritocracy as the basis for career progression, transfer and training.

5.3. Delinking of the Judiciary

Upholding the Constitutional mandate to preserve the sanctity of the Separation of Power and safeguard, uphold, and administer Justice fairly and independently without fear, favour, or undue delay, the personnels from the Judiciary formally delinked from Royal Civil Service Commission with effect from 15 February 2023. With the exception of 8 personnel, all the Judicial Personnel opted to separate from the Royal Civil Service Commission, thereby establishing an independent Human Resource. This resolute action solidifies the Judiciary's commitment to fostering an environment that inspires unwavering trust and confidence among all stakeholders while significantly enhancing the accessibility and integrity of our judicial system.

5.4 . His Majesty, the King grants audience

On 31st August 2023, His Majesty the King graced the Supreme Court with a visit, engaging in a meaningful discourse with the judicial luminaries. The distinguished gathering included the Chief Justice of Bhutan, Supreme Court Justices, High Court Chief Justice, and Justices, alongside Judges from the Thimphu Dzongkhag Court and Court Registrars of the Supreme Court and High Court. The judiciary, privileged to receive His Majesty's insights, stands blessed with the wisdom imparted during this momentous visit.

5.5. Removal

Upholding the principles of fairness and accountability within the judiciary, two Drangpons of the High Court were removed in response to the identified and confirmed instances of misuse of power and Judicial misconduct on 19 September 2023. The action taken aims to maintain the integrity and credibility of the judicial system, ensuring adherence to the established ethical standards and responsibilities incumbent upon holders of such esteemed positions.

His Majesty, the King appointed Drangpon Kinley Dorji as a Drangpon of the Supreme Court of Bhutan and Drangpon Kinley Namgay as a Drangpon of the High Court of Bhutan on 28 September 2023.

Drangpon Kinley Dorji formerly served as a Drangpon at the Royal Court of Justice, High Court. Drangpon Kinley Namgay formerly served as the Chief Judge of the Royal Court of Justice, Paro, The two Drangpons were appointed by His Majesty under Article 2 Section 19 of the Constitution.

5.7. His Majesty the Druk Gyalpo appoints the Hon. Chief Justice of Bhutan as the Chief Advisor of the Interim Government



His Majesty the Druk Gyalpo issued a Royal Decree appointing the members of the Interim Government on 1 November 2023 in accordance with Article 19, Section 1 of the Constitution of the Kingdom of Bhutan. His Majesty the Druk Gyalpo appointed the Hon. Chief Justice of Bhutan, Chogyal Dago Rigdzin as the Chief Advisor of Interim Government. The Royal Decree directed the Interim Government to ensure uninterrupted continuance of the routine functions of the government until the new Prime Minister enters office after the new National Assembly has been constituted.



5.8. Inauguration of the Royal Court of Justice, Gasa

The Officiating Chief Justice Drangpon Norbu Tshering inaugurated the new Royal Court of Justice, Gasa on 16 November 2023. The Court was constructed under the Royal Government of Bhutan funding of Nu. 33 million.



5.9. Inauguration of the Royal Court of Justice, Paro

Her Royal Highness, Princess Sonam Dechan Wangchuck inaugurated the new Royal Court of Justice, Paro on 22 November 2023. The Court has three Benches and features inclusive and disabled friendly court rooms. It was constructed under the Austrian Development Cooperation funding of Nu. 78 million.

5.10. Inauguration of the Royal Court of Justice, Sakteng



The Drungpa and Drangpon Rabgam of Sakteng Dungkhag inaugurated the new Royal Court of Justice, Sakteng on 9 December 2023. The Court was constructed under the Royal Government of Bhutan funding of Nu, 14.89 million.

The inauguration of the Royal Court of Justice, Paro, Royal Court of Justice, Gasa and Royal Court of Justice, Sakteng marks a commendable achievement towards ensuring fair and equitable Access to Justice. Notably, among the Dzongkhag Courts, modern court buildings are now operational in all eighteen Court, with the exception of the Royal Court of Justice in Chukha and Thimphu. Additionally, except for the Royal Court of Justice in Lingzhi, all fourteen Dungkhag Courts boast modern facilities within purpose-built court structures.

5.13. Reforms and Initiatives at the High Court

In a dedicated pursuit of fostering efficiency, collegiality, and accountability, the High Court has undertaken significant reforms in the reconstitution of its Benches. A pivotal change entails the presiding of the Chief Justice of High Court over all Benches, a strategic move towards consistency and centralized leadership. Complementing this, a dynamic system has been instituted, mandating the periodic alteration of Justice (s) compositions within Benches every 3-4 years. This deliberate rotation not only promotes a symbiotic working relationship but also affords Bench Clerks the invaluable opportunity to collaborate with all Justices, thereby enhancing fraternity and transparency in the common pursuit of delivering timely justice.

Underpinning these structural transformations are systematic changes including enhanced case deliberation processes accompanied by nuanced modifications in issuance of Marriage Certificate to Bhutanese marrying Foreigners involving the relevant organisations, judgment forms, drafting protocols, and case file submissions to the Supreme Court. This approach is underpinned by a visionary commitment to augmenting the efficacy and uniformity in the delivery and administration of justice.

To render user-friendly access to justice to litigants, a SMS alert system has been introduced whereby, the litigants receive real-time information pertaining to the relevant Bench, the dealing Bench Clerk, and the lead Justice overseeing their case. Such transparent communication channels not only empower litigants but also exemplify the High Court's dedication to ushering in an era of heightened connectivity and awareness within the judicial process.

Furthermore, the High Court has judiciously adopted an innovative approach towards litigation costs. In instances where appeals are dismissed, upholding the judgment of the trial court, an imposition one-three months of the minimum wage as litigation cost has been introduced. This pragmatic measure serves not only as a financial deterrent to frivolous appeals but also underscores the court's commitment to maintaining the sanctity of the legal process.
